The inspection report from the Assistant Inspector of Schools concerned along with relevant documents are enclosed for ready references and further necessary action.

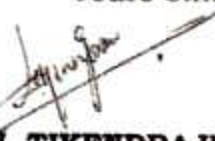
RECOMMENDATION:
